Donations and fund-raising amount down

Subs income held

Drop in turnover due to Covid

Resulted in a \$65,000 loss compared to a \$55,000 profit 2021

Balance Sheet: Current assets \$113,000 compared to \$219,000 2021

Deposits in advance up by \$10,000 indicating forward bookings are good for bigger events.

Gary presented a 3 yr. summary report: 2020-21 was subsidised by Govt covid subsidy, 2019-20 showed \$100,000 more in function profit

Coaching income has increased in 2022 but ran a loss due to retaining a coach over the winter. 2020 ran a profit, 2021 a small loss.

Purchase of Assets; 2021 the balance of grants and asset purchases was about right, 2022 club had to spend more on assets as grants were for a lower amount/half the value or less than applied for due to less funding from Covid impacts.

Dropped subs 2 seasons ago resulting in lower sub income, but this has now risen to same amount due to higher number of members.
